

The interdisciplinary nature of the courses required for this major attempts to look at the human experience both communally and individually as well as in both the past and present. The courses are approached from the liberal arts tradition of learning for the sake of learning and within the tradition of the humanities using great texts and looking at the "best of what has been thought and said". The courses cover a broad range of topics, generally include the primary works particular to the course subject, and have rigorous reading and writing expectations. I. Course Description

An intensive exploration of the relationship between warfare, state formation, and societal change in Europe from c.1450-c.1800. Topics covered: the Military Revolution Debate, Absolutism, the Wars of Religion, the General Crisis of the 17th Century, Contracting and Mercenaries, the Growth of Professional Navies and Standing Armies, State Finance, and Colonization. Students will then plan an archival research trip.

- 3. A general outline of events from c.1450-c.1800
